4. CITY BOULEVARD TREES ARE PLANNED FOR THE RESIDENTIAL STREETS IN ACCORDANCE WITH PLANS APPROVED BY THE CITY OF EDMONTON.
5. CITY BOULEVARD TREES ARE PLANTED IN ADDITION TO THE TREES REQUIRED BY THE DESIGN (ARCHITECTURAL) GUIDELINES FOR EACH RESIDENTIAL LOT AND DO NOT SATISFY THE DESIGN (ARCHITECTURAL) GUIDELINES REQUIREMENTS FOR RESIDENTIAL LOTS.
6. CITY BOULEVARD TREES MAY BE PLANTED SUBSEQUENT TO HOUSE CONSTRUCTION.
7. DIMENSIONS ARE IN METRES REFER TO SUBDIVISION PLAN TO CONFIRM ALL LOT INFORMATION.
8. EXISTING TREES ARE CONCEPTUAL ONLY AND MUST BE CONFIRMED.
9. ALL FENCES NOTED ON THE PLAN ARE LOCATED WITHIN THE PROPERTY LOT LINES.
10. THERE ARE RESTRICTIONS AND LIMITATIONS WITH RESPECT TO THE EASEMENT AND CONSERVATION AREA ON LOTS 58 & 59, +51 BLOCK 11; REFER TO THE EASEMENT AND RESTRICTIVE COVENANT REGISTERED ON TITLE FOR DETAILED INFORMATION. FOR ADDITIONAL INFORMATION ALSO REFER TO THE PURCHASER ACKNOWLEDGMENT FORM.
